There were no shares entitling the shareholders to attend and abstain from voting in favour pursuant to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). There were no shareholders that are required under the Listing Rules to abstain from voting. There were no restrictions on any shareholders to cast vote on any of the resolutions at the AGM.

Computershare Hong Kong Investor Services Limited, the Company's share registrars, was appointed as scrutineer for the vote-taking at the AGM.
